

COMMISSION OF PARDONS AND PAROLE

2012 Hearing Session Calendar

The hearing schedules are available seven (7) working days prior to the first day of each hearing session. The alpha-hearing schedules are posted by late afternoon on the Parole Commission web page in the "Schedule" section. **The decisions are posted by the fifth (5th) working day following the last day of each session.** *Hearing schedules are subject to change without notice. Hearings are conducted at the prisons and the exact locations are noted when the monthly schedules are posted.*

People wishing to attend a hearing should notify the Commission staff five (5) days before the first day of each session at (208) 334-2520. **No one under 16 years of age is allowed to attend parole hearings** (see Commission Administrative Rules section on web page). Written documents and letters must be submitted seven (7) days in advance of the hearing session.

Pocatello hearings: Parole hearings for inmates housed at PWCC (Pocatello Women’s Correctional), SAWC (St. Anthony Work Center), and CWC (Community Work Centers—Idaho Falls). ICI-O (Idaho Correctional Institute-includes Givens Hall—Orofino) will be done by videoconference from Pocatello.
