At PWCC, people will see the video. Please note the time differences so all wishing to attend in Orofino are there at PsT.**

**TIMES LISTED FOR VIDEOCONFERENCE:** Videoconference hearings will be held on Monday afternoon, 02/13 and Wednesday, 02/15. The morning sessions begin at 8:30 a.m. Mountain Standard Time (MST). The afternoon sessions begin at 1:00 p.m. MST. All times listed on this schedule are in MST. Since Orofino is on Pacific Standard Time (PST), one-hour earlier, people planning to go to Orofino to provide testimony at hearings need to be at the prison: Mon., 2/13 before 12:00 p.m. PST and on Wed. 2/15 before 7:30 a.m. (am session) and before 12:00 p.m. (pm session) to check in. Testimony from Orofino will be conducted via telephone, not via videoconference.
