If people go to Orofino to testify, they may have to testify telephonically only depending where the video is set up at ICI-O. At PWCC, people will see the video. Please note the time differences so all wishing to attend in Orofino are there at PST.

TIMES LISTED FOR VIDEOCONFERENCES: Videoconference hearings will be held on Tuesday, 11/6 and the morning of Wednesday, 11/7. The morning sessions begin at 8:30 a.m. Mountain Standard Time (MST). The afternoon sessions begin at 1:00 p.m. MST. All times listed on this schedule are in MST. Since Orofino is on Pacific Standard Time (PST), one-hour earlier, people planning to go to Orofino to provide testimony at hearings need to be at the prison: on Tuesday, 11/6 and Wednesday, 11/7, before 7:30 a.m. (a.m. session) and before 12:00 p.m. (p.m. session) to check in. Testimony from Orofino will be conducted via telephone, not via videoconference.
