The decisions are posted by the fifth (5<sup>th</sup>) working day following the last day of each session. *Hearing schedules are subject to change without notice. Hearings are conducted at the prisons and the exact locations are noted when the monthly schedules are posted.*

People wishing to attend a hearing should notify the Commission staff five (5) days in before the first day of each session at (208) 334-2520. No one under 16 years of age is allowed to attend parole hearings (see Commission Administrative Rules section on web page). Written documents and letters must be submitted seven (7) days in advance of the hearing session.
